### Conditions

1. The Institution should procure required teaching aid equipments for conduct of the course from time to time.
2. The institution should maintain continuously adequate classrooms for accommodation of 64 students in M.A. in Yoga course.
3. Infrastructure should be developed as per the needs of the students and as per the requirement of the course.
4. The institution should purchase adequate numbers of text books and reference books for the library keeping in view the changing requirements of the students and the syllabus.
5. The Institution should maintain adequate numbers of qualified teachers. During the appointment of teachers there should have an observer expert and a subject expert from Utkal University of Culture.
6. Fire fighting measures must be adopted in the institution.
7. Acquittance Roll should be maintained regularly. Subsidiary cash book should also be maintained regularly for the institution.
8. The institution should not admit the students beyond the sanctioned strength in any academic year.
9. The institution should provide adequate facilities for students with disabilities.
